## POLICE DEPARTMENT ACCREDITATION APPROVED; AWARDED APRIL 13

The Crestwood Police Department officially completed their final assessment on March 5 for accreditation through the Missouri Police Chiefs Charitable Foundation.

"The Missouri Police Chiefs Charitable Foundation accreditation increases the effectiveness and efficiency in which we can deliver law enforcement services to our community," said Chief of Police Jonathan Williams.

"This accreditation will help the Crestwood Police Department not only establish standards that address and reduce liabilities but it will also help the department maintain the most current best practices in the field of law enforcement."

The accreditation is nearly four years in the making for the City of Crestwood. Since 2017, Sgt. David Gray has been tasked with re-writing all of the Police Department's General Orders and Directives. These directives, the Department's policies and procedures, must follow 145 separate criteria set forth by the Missouri Police Chiefs Charitable Foundation.

On top of that, Sgt. Gray was tasked with three years of extensive record keeping, as the Police Department must prove each year that they follow all of these directives. Going forward, every three years, the Department will be reassessed to ensure they are maintaining the high level of service expected of every accredited agency.



"Our accreditation confirms the professionalism, hard work, and dedication of the Crestwood Police Department," said Chief Williams. "Sgt. Gray's performance as the Accreditation Manager was and is simply outstanding. The entire department is grateful for his hard work over the past three years. One of the assessors even said Sgt. Gray's organizational skills were some of the best he had seen in his many years doing this process."

At the Tuesday, April 13 Board of Aldermen meeting, representatives from the Missouri Police Chiefs Charitable Foundation will present the Police Department with their accreditation.

## CITY ELECTION APRIL 6



The City of Crestwood's general election will be held on Tuesday, April 6, 2021. On the ballot this year for all residents of Crestwood will be Proposition 1. A simple majority is required to pass the measure. The Official Ballot Language is listed below:

### City of Crestwood Proposition 1

"Shall the City of Crestwood be authorized to impose a semi-annual registration fee of \$200 to be paid by the owner of any residential structure in the City which has been vacant for six months or more and is in violation of the City's Housing codes?"

Additionally, four aldermen are on the ballot for Tuesday's election, one for each ward. These candidates are running for a three-year term. They are Jesse Morrison (Ward 1), Justin Charboneau (Ward 2), Scott Shipley (Ward 3) and John Sebben (Ward 4).

The new aldermen will be sworn in at the Board of Aldermen meeting on Tuesday April 27, pending certified election results from St. Louis County.

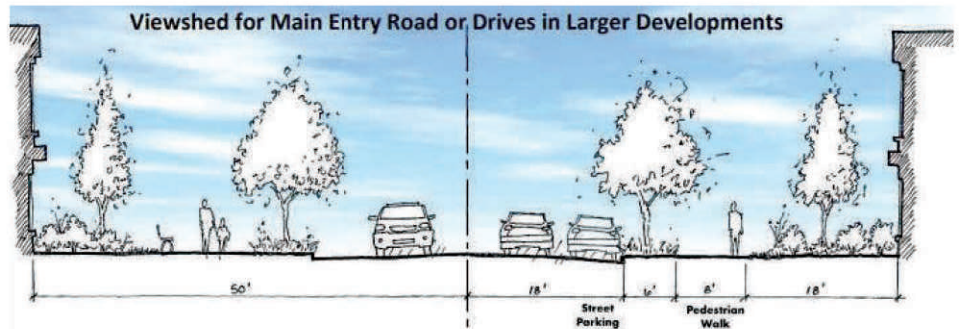
## SIXTH ANNUAL CRAFT FESTIVAL

# CITY APPROVES NEW ZONING CODE, WATSON ROAD OVERLAY AREA



In January, the Crestwood Board of Alderman passed a comprehensive update to the City's 300-plus page Zoning and Subdivision Code. Located in Chapter 26 of the City's Municipal Code, these 12 articles, with 78 sections, have been restructured as a Unified Development Code.

The overall process of the comprehensive update took nearly three years from the start in March 2018. After more than a year of reviewing the draft code with the Planning, Zoning, and Architectural Review Commission, as well as several public hearings along the way, the City brought the Zoning Code update to the Board of Aldermen in November 2020.

The Board hosted several additional meetings throughout December 2020 and January 2021 to discuss and make minor changes before finally approving the update at their January 12 meeting.

Below are some of the biggest changes from Chapter 26:

- The single largest change that occurred in the Chapter 26 rewrite was the adoption of an overlay for all properties along Watson Road. The Watson Road Overlay (Section 26-170) establishes a new streetscape along Watson Road – to encourage walkability by recommending building placements closer to Watson Road as well as establishing building material and architectural standards within the overlay.

- Another large change to the Zoning code is a brand new use table (Section 26-140). Previously, the City used NAICS

code, which provided a look at the highly specific use of a building, but did not take into consideration the scale or scope of said business. The new use table groups similar uses together and looks more at the scale of the business when considering appropriate locations.

- The City also streamlined the development application process. The changes put all of the most common procedures in one section (26-070) and reference all of the applicable subsections in the ensuing pages.

- Additionally, the City also took steps to reduce the amount of meetings applicants must attend, when appropriate. For any applications that no longer would go in front of the Board of Aldermen, the Board established a process called Power of Review, where they can still call up applications to review if they have concerns about the project.

- Fencing regulations were also revised. For example, corner lots previously had special regulations that have now been updated, allowing residents 20-30 feet of additional fence-able yards.

## Landscape Code Update

Lastly, in conjunction with the City's changes to the Zoning code, Crestwood is also currently in the process of updating its landscape code. ## CRESTWOOD CONSTRUCTION UPDATE: CHAMBERS COMPLETE, ADA RAMP NEXT

Construction throughout the City of Crestwood has been eventful so far in 2021. At the Crestwood Government Center, for example, crews have officially started phase three of the project at City Hall.

Phase three involves improving the front entrance of the building by sprucing up the doors and putting in an Americans with Disabilities Act (ADA) ramp and the accompanying handicapped accessible spots for use at the main entrance, instead of using a secondary entrance. Therefore, due to construction, the main entrance will be closed through the end of May or early June (pending weather delays), while the project is underway.

This comes on the heels of the completion of phase two in the interior of the building. Phase two involved updates to the main floor of the Government Center building where crews rebuilt the Board of

There are also two other major projects currently underway at Whitecliff Park. Construction has begun on the boardwalk and brand new pavilion around the Quarry area. Both projects have been funded by various Municipal Park Grant Commission grants and the City is excited to see the projects come to life. Work is scheduled to be completed in Winter 2021.

## \$1.2 MILLION BRIDGE GRANT AWARDED

Several years ago, the State of Missouri -- who monitors the condition of all bridges that span more than 20 feet -- informed City staff that due to its age, the Whitecliff Park Lane Bridge would need replacement in the coming years.

Last year, the bridge's condition reached the point where replacement was recommended in the near future. The City applied for a Surface Transportation Block Grant with the Federal Highway Administration and received a \$1.2 million federal grant to replace the bridge. The City will contribute \$300,000, bringing the total project cost to \$1.5 million.

The City will be seeking bids to hire a firm to complete the bridge design, with work scheduled to begin in late 2022 or early 2023.
