NIBRS First Quarter:

Crestwood Police Department submits all crimes reported to the FBI's National Incident-Based Reporting System or NIBRS. This has become the standard for law enforcement crime data reporting in the United States. NIBRS captures details on each single crime incident—as well as on separate offenses within the same incident—including information on victims, known offenders, relationships between victims and offenders, arrestees, and property involved in crimes. The broad scope of the information collected in NIBRS provides greater specificity in reporting offenses, collects detailed information, helps give context to specific

crime problems and provides greater analytic flexibility. Below is the NIBRS data for the Crestwood Police Department from the First Quarter of 2023.




There were 17 persons taken into custody during the First Quarter of 2023. The gender and ethnicity of those persons are as follows

In the First Quarter of 2023 there were 48 Traffic Accidents. These accidents were of the following classifications.








Bureau Statistics:

As of The end of First Quarter 2023, a total of 27 cases are still marked *Active*. Not counting those that are still *Active*, the clearance rate for the bureau in March was 64.1%, which is slightly down from 69.6% in February. That percentage has begun to normalize after clearing cases from 2022 in January and February of 2023. The below charts reflect the work of the Detective Bureau YTD.

In the nation, in 2019, 45.5 % of violent crimes and 17.2 % of property crimes were cleared by arrest or exceptional means according to the Criminal Justice Information Services Division.

First Quarter 2023 Bureau Highlights:

On February 15, 2023, employees of Crestwood Ace Hardware contacted the police department to report a W/M customer entered the business and exposed himself to store employees. Detectives were able to locate the store reward points used by the suspect which were traced to a business. The owner identified the employee who used his reward card. That person matched the images observed on the in-store video surveillance and was positively identified by the employer. Warrants against the suspect have been sought with the Prosecuting Attorney's Office.

On March 7, 2023, officers responded to the Crestwood Kohls Department Store for a report of a fraudulent return. Officers discovered a male suspect had used counterfeit US currently to purchase items at the Arnold location of Kohls, which were later returned to the Crestwood store. During the investigation, detectives found the currency used in Arnold matches the counterfeit money used to make a fraudulent purchase in Crestwood on a different date. That merchandise was later returned to the Fenton location of Kohls. Video footage of the suspect vehicle identified a license plate that was registered to a male who was able to be positively matched to the purchase in Arnold and the return in Crestwood. The reward points used by the second suspect in Crestwood were found to return to a male

who was found to match the video images of the fraudulent purchase in Crestwood and the return in Fenton. The case has been turned over to the United States Secret Service who are seeking federal charges on both suspects.

On March 13, 2023, officers responded to the Crestwood Plant Fitness for a report of locks cut off several lockers and items stolen from inside. During the initial investigation, officers discovered the suspect entered, provided a false identification applying for a membership, and proceeded to the men's locker room, leaving a short time later. They also discovered a male matching the suspect's description had also stolen from another local Plant Fitness. Detectives were able to locate the vehicle driven by the suspect and located the same vehicle on the Flock camera system. The owner of the vehicle, who lives in Chicago, Illinois, verified the vehicle belonged to her and identified the driver as her nephew. Video evidence also corroborated the identity. Charges against the suspect have been sought with the Prosecuting Attorney's Office.

On March 18, 2023, Officers responded to the Crestwood McDonald's for a report of a burglary where the suspect stole money during the overnight hours from a safe. During the investigation, detectives discovered the code utilized to open the safe returned to a female employee who was later terminated. Store officials also suspected a former male employee who had been recently terminated for an internal theft as the person who stole from the safe. That suspect was identified and his residence was located in Crestwood. Detectives located numerous video images of the suspect walking to and from his residence and McDonald's. The suspect is actively being sought at this time.
