NIBRS Second Quarter:

Crestwood Police Department submits all crimes reported to the FBI's National Incident-Based Reporting System or NIBRS. This has become the standard for law enforcement crime data reporting in the United States. NIBRS captures details on each single crime incident—as well as on separate offenses within the same incident—including information on victims, known offenders, relationships between victims and offenders, arrestees, and property involved in crimes. The broad scope of the information collected in NIBRS provides greater specificity in reporting offenses, collects detailed information, helps give context to specific

crime problems and provides greater analytic flexibility. Below is the NIBRS data for the Crestwood Police Department from the Second Quarter of 2023.




There were 12 persons taken into custody during the Second Quarter of 2023. The gender and ethnicity of those persons are as follows:



In the Second Quarter of 2023 there were 43 Traffic Accidents. These accidents were of the following classifications.







Bureau Statistics:

As of the end of Second Quarter 2023, a total of 29 cases are still marked *Active*. Not counting those that are still *Active*, the clearance rate for the bureau at the end of June was 65.2%, which is slightly up from 65.1% in May. The below charts reflect the work of the Detective Bureau YTD.

In the nation, in 2019, 45.5 % of violent crimes and 17.2 % of property crimes were cleared by arrest or exceptional means according to the Criminal Justice Information Services Division.

Second Quarter 2023 Notes from the Bureau:

During the Second Quarter of 2023, detectives investigated numerous cases where persons from other states came to Missouri, committed criminal acts and returned to their home state.

On April 3, 2023 officers responded to the theft of a wallet from Planet Fitness. Detectives were ultimately able to identify the suspect who was found to be living in Florida. Warrants were issued by the St. Louis County Prosecuting Attorney's Office for Felony Theft and Fraudulent Use of a Credit Device.

On April 24, 2023 a female stole \$168.00 in food from Schnucks and fled the area. Detectives were able to identify the female who lives in East St. Louis. Charges have been sought with the City of Crestwood Municipal Prosecutor.

In another case on May 25, 2023 officers were called to Dierbergs for a reported theft of a wallet from the shopping cart of an elderly female. Investigation has identified suspects from Chicago and pending records requested through a court order, charges will be sought with the St. Louis County Prosecuting Attorney's Office.

Internal thefts are also becoming more of an issue.

One case, reported, at Crestwood Bowl where an employee had stolen payroll checks and cashed them. After obtaining subpoenas, detectives were able to identify the suspect who was later arrested, and charges have been sought with the St. Louis County Prosecuting Attorney's Office.

Another internal theft was reported at Taco Bell where the suspect, an employee, used a customer's credit card to make numerous purchases. The suspect has been identified and charges sought with the St. Louis County Prosecuting Attorney's Office.

Detectives have also been more active in working with federal authorities seeking charges.

On April 24, 2023 an elderly victim reported an unknown person took out a fraudulent disaster assistance loan in their name. Detectives have been in contact with the FBI who has taken over the investigation.

Other current cases are also being assumed by federal authorities and the US Marshalls are working to assist in arresting a violent felon currently under investigation.

The robbery at Circle K reported on June 28, 2023 is still being investigated and detectives are waiting for subpoenas to be returned to conduct further. A person of interest has been identified and the investigation is ongoing.
