## GENERAL MUNICIPAL ELECTION, APRIL 2



Calling voters of Crestwood! This year's General Municipal Election will be held on Tuesday, April 2, 2024. On the ballot for all residents of Crestwood will be Proposition A - a Special Bond Election. To pass this measure, a 57.14% majority of all Crestwood voters is required. The Official Ballot Language is listed below:

### City of Crestwood Proposition A

"Shall the City of Crestwood, Missouri, issue its general obligation bonds in an amount not to exceed \$ 33,340,000 for the purpose of constructing, furnishing and equipping a new community center, renovating existing recreation facilities, and undertaking other park and recreation improvements in and adjacent to City of Crestwood parks?"

Additionally, voters will elect four aldermen, one from each of the City's four wards to serve until April 2027.

## ELECTION JUDGES NEEDED

For the upcoming April 2 General Municipal Election, the St. Louis County Election Board is in great need of more election judges and student election judges to serve the public. Election judges are awarded a stipend of at least \$250 for their service, while students have the option to receive 16 community service hours or \$170 in pay for their work.

# STRATEGIC GOALS AND PRIORITIES

The Board of Aldermen held their annual goal setting workshop for the purpose of deciding long-term strategic priorities for the City.

"I'm proud of the strategic direction our Board has set for 2024. The priorities and goals are important to all of us and reflect the character of Crestwood," said Mayor Scott Shipley. "These goals are not just a roadmap for our city's development; they are a commitment to our residents' quality of life."

During this year's workshop, the Board of Aldermen set a focus on five pillars – Governmental Excellence, Vision and Growth, Quality of Life, Premier Public Safety, and Engaged and Connected Community.

### Governmental Excellence

Within governmental excellence, the objectives are to keep the City fiscally responsible and transparent, promote a highly trained and qualified staff, and provide high-quality customer service to all residents. Some of the projects intended to achieve those objectives include providing online permit capability, implementing a long-term maintenance plan for all City-owned properties, and reviewing the City's recruitment and retention strategies.

### Vision and Growth

The objectives of this pillar are supporting economic development, improving public infrastructure, and promoting a well-maintained and attractive community. Specific projects include working with MoDOT and Metro to install new bus stops along Watson Road, developing a sidewalk expansion policy, and working through an overall City beautification plan, which includes additional art and signage.

### Quality of Life

The quality of life objectives focus on promoting physical and emotional health through quality parks, facilities, and programs. A continued effort in creative

programming for all ages and developing a long-term parks improvement and maintenance plan is just one of the projects.

### Premier Public Safety

Ensuring effective emergency response capabilities, leveraging infrastructure to improve public safety and active community engagement are focused objectives for this pillar. In addition to ongoing improvements already underway, the projects associated with premier public safety include expanded implementation of the City's traffic calming and streetlight policies.

### Engaged and Connected Community

This pillar is focused on community involvement through outreach and transparency. These projects include an increase in event signage and City updates throughout the community, implementing more access to elected officials and City staff, and promoting additional volunteer opportunities and events for all residents and businesses within Crestwood.

"To make these goals a reality, I encourage every resident to engage with us—attend city meetings, participate in community events, and provide your feedback," Mayor Shipley noted. "Your involvement is key to our success. Let's work together to make Crestwood a great place for all of us."


outdoor concert series, or signing up for classes at the community center. Invite a neighbor too! These are excellent ways to connect and engage with our vibrant community.
