Dear Residents,

“So, what’s going on in Crestwood?”

That’s a common question I hear from people who live outside of our area. For the past few years, it’s been great to share news about the construction at Crestwood Crossing, the new businesses in our City, and the renovations that other businesses have undertaken. We all share in that success, and people outside of Crestwood have noticed.

In 2024, we have a new chapter of that story to share. As you surely know, Proposition A passed with 60 percent support citywide. This marks a new milestone for Crestwood, and again, we will all share in that success.

The changes coming as part of Prop-A are historic for Crestwood and should not be underestimated. They will help bring everyone together as a community and will literally help to improve our health and wellbeing. Designs for the new building will be finalized by the end of the year with construction planned to

begin in 2025.

There are more exciting and important projects happening all around the City this year. This includes more than \$1 million in improvements to our streets and sidewalks as well as many new parks projects. Ferndale Park will see a completely new and



upgraded playground. The main bridge into Whitecliff will be replaced, starting after the summer busy season. The Aquatic Center will get a new roof after 20+ years of service. A new restroom will be installed at the Quarry, and the Whitecliff lower parking lot will be expanded to handle the increased popularity of that site. Sanders and Spellman Parks will receive improved lighting. And thanks to a dedicated Crestwood volunteer, all the windows at the Historic Sappington House are being restored.

The Fire Department will take delivery of the City’s new firetruck this spring that has been planned for many years,

## PROP A UPDATE

With the April 2 General Election, the voters of Crestwood approved Proposition A for the purpose of constructing and furnishing a new community center, renovating the existing facility, and undertaking other park and recreation improvements within Crestwood parks.

With this voter approval, the City will work with the project architects, engineers, and other experts and stakeholders to formalize construction plans with the goal of going to bid for a general contractor in Spring 2025.

From there, construction of the new community center and the nature playscape is scheduled to begin soon after in 2025, with possible completion by the end of 2026.

Once that portion of the project is complete, the existing building will be reimagined and turned into the pickleball and family games complex. That portion of the project is anticipated to take another 18 months, pending the opening of the new center.

As for the other projects, the new playground and surfacing replacement at Crestwood Park will be completed in 2025, while the loop trail addition and pedestrian bridge from Lodge Pole/Sheryl Ann at Whitecliff Park will be done in a yet to be determined time frame, most likely between 2025-2027.

The timeline of these projects will be finalized in connection with the completion of the Whitecliff Park Lane bridge replacement project, as to minimize the usage of Vauk Drive.

## MUNICIPAL ELECTION RESULTS

Tuesday, April 2 was the general municipal election throughout the State of Missouri. On the ballot for all voters was Proposition A. That ballot measure passed with 2,183 votes for and 1,467 votes against.

Additionally, in each of the City's four wards, four aldermen were elected to serve three-year terms through April 2027. They are:

- Ward 1: Jesse Morrison
- Ward 2: Rebecca Now
- Ward 3: Grant Mabie
- Ward 4: John Sebben

## ETCH-AND-CATCH PROGRAM

For those that might have missed the update last year, the police department has partnered with local repair shops to uniquely identify the catalytic convertor on your vehicle. The repair shop, free of charge, will etch your license plate number on your convertor, which will help deter theft, and if stolen, can assist in the investigation into the theft. ## CODE ENFORCEMENT CORNER

As a reminder, please make sure to continuously take care of your property. All grass must be below 7" in length at all times and all grass clippings should either be spread out and mulched into the lawn or bagged and properly disposed of, not left in piles on the lawn. # CITY PROGRAMS AND SERVICES

The City of Crestwood is known for their premier public safety and superior parks and recreation services. What some in the community may not know about is how many services the City provides that are free, or low-cost, to residents of Crestwood.

For example, if you are interested in receiving a FREE street tree planted for you along your property, from our trained professionals in the parks maintenance division, please reach out to our parks and recreation department. Applications can be found on the City's website and are accepted on an ongoing basis, throughout the year. Trees are limited annually due to budgetary constraints, so this is a first come, first serve basis. Trees are typically planted in the fall, when they have the best chance of survival. *Please note, not all properties can accommodate a street tree, so restrictions apply.*

The parks department also has a commemorative tree/bench program, where parks staff will work with the applicant on where to locate the tree/bench in one of the City parks. The application can be found on the City's website and has an associated fee.

## Fire Department

The Crestwood department of fire services provides free assistance replacing batteries in smoke detectors for elderly Crestwood residents. All the resident needs to do is reach out to the crews on duty and they will investigate smoke detectors and replace batteries for those residents in need of that service. To contact the fire department, please dial their main directory at 314-729-4740.

The department also provides free CPR and AED training as well as fire extinguisher training for schools, businesses, and community groups in Crestwood. Those interested in said training can reach out to the department's deputy chiefs for more information and scheduling.

## Police Department

One of the many services that the police department provides is the free vacation watch service. If you are away on vacation, patrol officers will check on your address multiple times to make sure the home and property are safe and secure. A vacation watch request can be submitted through the police department page on the City website.

The department also has their own free, Tip411 smartphone app that can be found by searching Crestwood MO PD on Google Play or the Apple App Store. The app lets users send anonymous tips directly to and receive important alerts directly from the department. Users can also start an anonymous, two-way conversation with an officer/detective, which has led to important leads and cases closed throughout the time the department has been utilizing the app.

The police department is always willing to provide a tour of the station or provide safety talks to your organization, group, or business. ## BEAUTIFICATION GRANTS

Any City of Crestwood resident(s) or neighborhood group could be eligible to receive up to a \$500 grant to beautify a public right-of-way, public space, common ground, or even private property with one of the City's beautification grants. FY2024 grants will be accepted through this July.

## REMINDER: ADDRESS IDENTIFICATION

Recently, it has come to the City's attention that there are multiple residences within the City that do not have approved address identification posted on the exterior of their property.

This is concerning to the City as a lack of proper identification can delay an emergency response in the event you or your neighbors might need assistance.

Residential and commercial buildings are required to place the numerical address of the building in a conspicuous location that is visible from the street.

On a residential structure, for example, this identification is typically put around the front door, above the garage, and/or on the mailbox in the right-of-way.

For reference, the posted address characters must follow these guidelines:

- Characters shall contrast with the background
- Address numbers should be Arabic numbers or alphabetical letters
- Numbers shall not be spelled out
- Each character shall not be less than 4 inches high with a minimum stroke width of 1/2 inch
