

WHITECLIFF PARK BRIDGE TO BE REPLACED

The bridge at the main entrance of Whitecliff Park will be removed and replaced, starting this September. The project mobilization period began right after pool season ended on Labor Day, with the bridge itself coming down later this month. Completion of the project will take place by Memorial Day 2025, before the start of next year's pool season.

During this construction period, all visitors to Whitecliff Park and the Whitecliff Community Center will be required to enter through the one lane in, one lane out temporary entrance/exit at the upper parking lot (near the tennis courts), along Vauk Lane. **The GPS destination for the temporary park entrance is 9255 Vauk Lane.**

Once the new bridge is complete in 2025, the temporary entrance off Vaux Lane will be blocked off and only used for emergencies.

To help defer the costs of the newly constructed bridge, the City is working in partnership with the State of Missouri and the U.S. Department of Transportation. About five years ago, the State of Missouri, who monitors the condition of all bridges that span more than 20 feet, informed



City staff that due to its age, the Whitecliff Park Lane Bridge would need replacement in the coming years.

When the bridge's condition reached the point where replacement was fully recommended, the City applied and successfully received a \$1.2 million Surface Transportation Block Grant from the Federal Highway Administration to replace the bridge. In total, the grant will fund more than two thirds of the forthcoming project costs.

The Cities of Crestwood and Sunset Hills are excited for the sixth annual SunCrest Fest on Saturday, September 21 at Kitun Park (12343 Eddie and Park Road), next to Truman Middle School.

SunCrest Fest fairgrounds open at 11:00 A.M. and the event lasts until 8:00 P.M. The fairgrounds will feature professional carnival rides with two large attractions, classic carnival games, live music, numerous food booths, kids activities, and more.

Ride bracelets will run \$35 for an all-day bracelet, if bought during the week before (\$40 day of the event). Half-day bracelets for either 11:00 A.M. to 3:00 P.M. or 4:00 to 8:00 P.M. will run \$25 (\$30 day of). Bracelets will be sold at both the Crestwood and Sunset Hills Community Centers.

The day will kick off with a parade down Eddie and Park Road starting at 10:15 A.M., followed by a car show in the Truman parking lot from 11:00 A.M. to 2:00 P.M.

Live music will be played throughout the afternoon and evening including Rock Opera from 2:30-4:30 P.M. and Almost Famous from 6:00-8:00 P.M. DJ Shaggy Sounds will be playing music throughout the day, between live performances.

NEWS BLURBS

CITY'S BUDGET AWARDED

The City was recently awarded the Distinguished Budget Presentation Award for their FY2023 budget, by the Government Finance Officer's Association (GFOA). In order to receive this award, which was only awarded to less than 40 municipalities in the State, the City had to satisfy dozens of nationally recognized guidelines for effective budgets. This is the City's ninth consecutive Budget Award.

CRESTWOOD NIGHT OUT

Crestwood Night Out is a long standing event sponsored annually by the Police Department in an effort to bring neighbors together and strengthen community bonds. This year's event will be held on Saturday, September 14 from 5:00-9:00 P.M. Neighborhoods throughout Crestwood organize events such as block parties, ice cream socials, and outdoor movie nights.

PAPER SHREDDING EVENT

The City will be hosting a Paper Shredding Event on Saturday, October 12 from 9:00 A.M.-Noon at the Crestwood Government Center. The City partnered with the St. Louis County Department of Public Health, utilizing County landfill surcharge funds to provide this event FREE of charge to all Crestwood and St. Louis County residents.

WATSON RD PROJECT UPDATE

While originally scheduled to begin in summer 2024, MoDOT's Watson Road project start date will now be Spring 2025. The project will resurface the entirety of Watson Road from I-44 to the City of St. Louis limits, improve all existing sidewalks/crosswalks to current ADA standards, and replace the bridge over Gravois Creek (between Brookview Drive and Pardee Lane) in Crestwood. The current construction completion date is Fall 2027.

PROP A: CRESTWOOD PARK PLAYGROUND

One of the main Prop A projects of note is the replacement of the aging playground at Crestwood Park - the largest and busiest playground in the City - with a brand new playground and safety surfacing in 2025.

Over this summer, the City's Parks and Recreation Department took all of the previous suggestions provided, along with potential vendor designs, to the Crestwood Park Board in August and the students of Long Elementary School to help narrow down their choices. Once complete, the narrowed down, final recommendations will be forwarded to the Board of Aldermen, who will review the plans for formal approval by the end of the year.



Construction of the new playground is scheduled to begin in early 2025, with completion expected later that year.

Other Project Updates

The City is also proactively working towards the new community center in Whitecliff Park. Throughout the summer, the City has been meeting with the project architects, stakeholders, and others to finalize design plans and work through all of the proper site due diligence needed for a project of this scale.

Later this fall, the final development plans will be presented at a Board of Aldermen meeting and the formal bond issuance will occur. The project is still on track to begin in 2025.

CODE ENFORCEMENT CORNER: PERMITS NEEDED

The City would like to remind all residents that if they or a contractor are doing any sort of major work to their properties, it is probable that a permit would be required for the work being performed. While it can feel burdensome to pull permits with both the City of Crestwood and St. Louis County, the purpose of every permit is to protect what you value most – your family and your home.

Permits and inspections help protect your loved ones from faulty construction/installations, which can lead to potentially catastrophic mistakes, such as house fires, flood damage and structural problems.

These minor inconveniences help you avoid those costly repairs down the line and preserve your home's value, your biggest financial investment. When selling your home, you may be required to fully disclose all remodeling work and correct, or even remove, unpermitted non-compliant work.

Permits are required for many reasons that people are aware of such as room additions, interior remodels, and structural changes to the main or accessory structure

on a property. They are also needed for reasons that people might not realize including decks, balconies, porches, fences, driveways, retaining walls (over two ft.), excavations, grading, fire escapes, swimming pools (over 24 in.), concrete or asphalt slabs (over 200 sq. ft.) and much more,

PERMITTING SOFTWARE

To assist in helping property owners secure permits and licenses in the most efficient manner, the City is working with the Davenport Group to create an online permitting software system.

This software, which is set to be operational around the end of 2024, will feature an online user interface, ability to upload documents and plans without coming into City Hall, and the capability to pay by credit card, in addition to the services the City already provides.

POLICE DEPARTMENT REACCREDITATED

Earlier this summer, the Police Department completed their second accreditation process with the Missouri Police Chiefs Charitable Foundation. The Department was first accredited in 2021, and every three years must earn reaccreditation through the Foundation.

The reaccreditation process involves a thorough review of 209 Missouri State Standards submitted to the assessors, interviews with Police Department employees, and an on-site inspection of our facilities. The assessment found the Department is currently in compliance with State Standards and met the criteria for reaccreditation.

"Our reaccreditation with the Missouri Police Chiefs Charitable Foundation confirms our commitment to professionalism and compliance with best practices in law enforcement," Police Chief Jonathan Williams said.

"Our flawless assessment is a testament to the dedicated service provided by the men and women of the Crestwood Police Department."

The Crestwood Police Department will be up for review and reaccreditation in June 2027.
