### MAYOR'S MESSAGE:

## Season of Progress in Crestwood

As we move into the heart of summer, there's a lot happening in Crestwood that I'm excited to share with you.

In June, the City launched a new monthly e-newsletter, Crestwood Connect. It's one of the best ways to stay informed about upcoming events, City services, and important news that affects us all. The Joseph Sappington log cabin reconstruction at Sappington Park is moving forward. The Historic Sappington Foundation has worked for years to make this project a reality, and their efforts will soon result in a revitalized landmark that adds to our City's character. Once completed, the restored cabin will enhance the area's historic significance, serve as a small event space, and align with the long-term master plan for the park.

Progress is also being made on major park improvements made possible by the passage of Proposition A. On May 6, we celebrated the opening of two new playgrounds at Crestwood Park—the first completed projects funded through Prop A. Judging

by the number of kids and families enjoying them each day, they're already fulfilling their purpose. These improvements were designed to meet the needs of our entire community, and we're just getting started.

On May 23, we broke ground on the new Community Center, with construction now underway and completion targeted for the end of 2026.

This is the largest investment in parks and recreation in our City's history, and once finished, it will offer a welcoming space for residents of all ages to enjoy for years to come.

Thank you for your patience during the replacement of the main bridge in Whitecliff Park. It closed last September, and while the detour helped us get by, we were all thrilled to see the new bridge open in April—about a month ahead of schedule.

This is another long-term investment in Crestwood's infrastructure that will serve our community well.

You may have also noticed the new Crestwood-themed banners along Watson and Sappington. Each one highlights a different aspect of life in Crestwood under the theme "A Place For \_\_\_\_." Just as important, all images featured are actual Crestwood residents and City staff. These aren't stock photos—they're our neighbors and coworkers. That was intentional. The banners are a reminder that Crestwood's strength lies in its people, and in the many ways we show up for one another.

# Crestwood Citizen's Academy Returns

## Code Corner: Flatwork

If you're installing or replacing more than 200 square feet of impervious surface (like concrete, asphalt, or pavers), a flatwork permit is required. This includes new patios, driveways, walkways, and other hardscapes. Impervious surfaces prevent water from soaking into the ground, which can lead to increased runoff that contributes to erosion, property damage, and strain on the City's stormwater system.

If your project increases the total amount of impervious surface, you'll also need to include stormwater management techniques in your application.

Your submittal should include a plan showing the location of the work—and stormwater solutions, if required. To apply for a permit, click the "Permits & Licenses" icon on the



homepage of the City's website.

Not sure if your project qualifies? Here are some quick examples:

- Replacing a 200 sq. ft. patio? **Permit needed**
- Replacing and expanding beyond 200 sq. ft.? **Permit needed**
- Adding 200 sq. ft. next to an existing patio? **Permit needed.**
- Adding less than 200 sq. ft. without touching the existing patio? **No permit needed.**

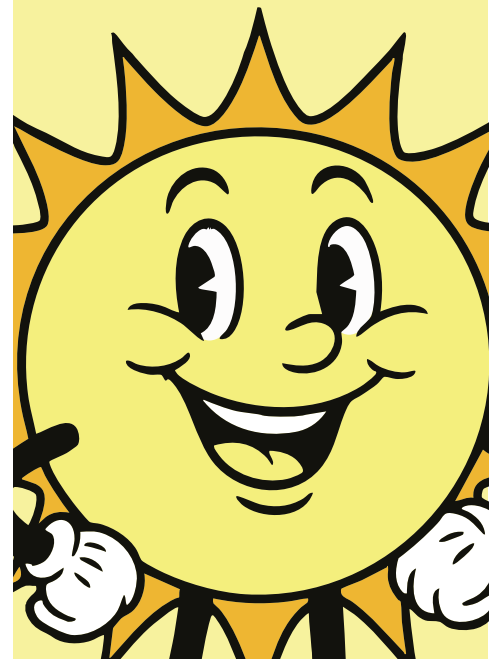
