

## MAYOR'S MESSAGE

JUNE 2019

**NOW THAT SUMMER** is approaching, I hope everyone will have more time to enjoy the outdoors in Crestwood's Parks. At the Crestwood Aquatic Center in Whitecliff Park, you can enjoy a multi-purpose lap pool with two diving boards, lazy river, family play pool with three slides, climbing wall, and a zero depth beach area among other things. In addition to the pool's amenities, Crestwood staff offers a wide range of Aquatics Fitness Classes from June through August. Aquatic Center individual and family membership passes are available to Crestwood residents at a discounted rate, and pass holders may bring up to four paid guests daily. Information about membership passes and aquatic fitness classes can be found in the Crestwood RecConnect Guide on the City Website.

Additionally, be sure to check out Crestwood's Summer Series events, including Movies in the Park, Books in the Park, and

Concerts in the Park! More details and a full schedule are provided on page 3 of this newsletter.

Crestwood is continuously working to upgrade its parks. One exciting piece of news I am happy to announce is that Crestwood has been preliminarily awarded a \$125,000 Land and Water Conservation Fund grant. The funds from this grant will enable us to construct new features at the quarry area in Whitecliff Park. This has been a project the City has wanted to pursue for 20 years since our 1999 Whitecliff Park Master Plan! The City is still awaiting the official notice to proceed from the National Park Service and Missouri Department of Natural Resources, which is expected in September or October of this year. Upon receipt, the City will have 12 months to begin construction on the project,

### CRESTWOOD PROPERTY TAX ROLL BACK PROJECTED



In 2019, the St. Louis County Assessor reassessed the fair market value on all residential and commercial property located within St. Louis County. The assessed value is applied to tax rates established by the taxing districts to determine the amount of tax levied against a property.

While the 2019 preliminary values show a 21% increase in Crestwood's assessed values, property taxes collected by the City of Crestwood will only increase by 1.9% due to the Hancock Amendment of the Missouri Constitution.

The Hancock Amendment limits the tax increase to the increase in the consumer price index (CPI), which this year is 1.9%. While most property owners will see an increase in their assessed values, their taxes won't increase by the same percentage. The result is a reduction in Crestwood's preliminary property tax rate to .5920, down 15% from last year's rate of .6980.

In 2018, the assessed value of a \$200,000 home was \$38,000. The Crestwood Residential Property Tax rate of \$0.6980 generated \$265 in City of Crestwood property taxes.

After a 21% increase for 2019 the assessed value of the same house rises to \$45,980. With a preliminary residential property tax rate of .5920, the 2019 property tax bill is \$272, just \$7 more than 2018.

## SUMMER STREET REPAIRS

The following city streets have been designated for slab replacement in 2019: Dalcrest Lane, Raycrest Lane, Arban Drive, Buxton Drive, and Glencrest Drive. Starting on June 3, residents can expect to encounter construction work and partial street closures. The project is expected to take approximately 8 weeks.
