For sale of intoxicating liquor of all kinds at retail, by the drink and for consumption on the premises where sold, and the sale of intoxicating liquors in the original package.
- \_\_\_\_\_ **BEER & WINE LICENSE (Monday through Saturday)** **\$200.00 per year**  
For sale of intoxicating liquor and malt liquor in excess of 3.2% of alcohol by weight, but not in excess of 14% of alcohol by weight, by the drink and for consumption on the premises.
- \_\_\_\_\_ **BEER LICENSE (Monday through Saturday)** **\$52.50 per year**  
For sale of malt liquor containing alcohol in excess of 3.2% of alcohol by weight and not in excess of 5% of alcohol by weight, by the drink and for consumption on the premises.
- \_\_\_\_\_ **PACKAGE LIQUOR LICENSE (Monday through Saturday)** **\$75.00 per year**  
For sale of intoxicating liquor in the original package not to be consumed on the premises where sold.
- \_\_\_\_\_ **WINE TASTING LICENSE FOR PACKAGE LIQUOR DEALERS** **\$25.00 per year**  
For wine tasting when permit issued by the State Supervisor of Liquor Control.
- \_\_\_\_\_ **PACKAGE BEER LICENSE (Monday through Saturday)** **\$22.50 per year**  
For sale of malt liquor containing alcohol in excess of 3.2% of alcohol by weight and not in excess of 5% of alcohol by weight, in the original package.
- \_\_\_\_\_ **SUNDAY SALES LICENSE** **\$300.00 per year**  
For sale of intoxicating liquor of all kinds at retail, by the drink and for consumption on the premises where sold, and the sale of intoxicating liquors in the original package.
- \_\_\_\_\_ **SUNDAY SALES LICENSE FOR PACKAGE LIQUOR DEALERS** **\$300.00 per year**  
For sale of intoxicating liquor in the original package at retail between the hours of 9:00 a.m. and 12:00 midnight on Sundays.
- \_\_\_\_\_ **FOR MANUFACTURERS, OTHER THAN MICROBREWERS** **\$375.00 per year**  
For a manufacturer, other than a microbrewer, distiller, or brewer of intoxicating liquor.
- \_\_\_\_\_ **FOR WHOLESALER OF INTOXICATING LIQUOR** **\$150.00 per year**  
For a wholesaler of intoxicating liquor.
- \_\_\_\_\_ **FOR MICROBREWERS** **\$375.00 per year**  
For Microbrewers a fee of \$7.50 for each one hundred barrels or fraction thereof, up to a maximum fee of \$375.00
- \_\_\_\_\_ **FOR TEMPORARY LICENSES** **\$25.00 per year**  
For not more than seven (7) days and if the event will be held on a Sunday, the permit shall begin at 11 a.m.
