For sale of intoxicating liquor of all kinds at retail, by the drink and for consumption on the premises where sold, and the sale of intoxicating liquors in the original package.

_____ **BEER & WINE LICENSE (Monday through Saturday)**

For sale of intoxicating liquor and malt liquor in excess of 3.2% of alcohol by weight, but not in excess of 14% of alcohol by weight, by the drink and for consumption on the premises.

\$200.00 per year

_____ **BEER LICENSE (Monday through Saturday)**

For sale of malt liquor containing alcohol in excess of 3.2% of alcohol by weight and not in excess of 5% of alcohol by weight, by the drink and for consumption on the premises.

\$52.50 per year

_____ **PACKAGE LIQUOR LICENSE (Monday through Saturday)**

For sale of intoxicating liquor in the original package not to be consumed on the premises where sold.

_____ **WINE TASTING LICENSE FOR PACKAGE LIQUOR DEALERS**

For wine tasting when permit issued by the State Supervisor of Liquor Control.

\$25.00 per year

_____ **PACKAGE BEER LICENSE (Monday through Saturday)**

For sale of malt liquor containing alcohol in excess of 3.2% of alcohol by weight and not in excess of 5% of alcohol by weight, in the original package.

\$22.50 per year

_____ **SUNDAY SALES LICENSE FOR RESTAURANT/BARS**

For Licensees who qualify as restaurant/bars under statutes of Missouri, sale of intoxicating liquor on Sunday between the hours of 9:00 a.m. to 12:00 midnight on Sunday.

\$300.00 per year

_____ **SUNDAY SALES LICENSE FOR PACKAGE LIQUOR DEALERS**

For Sale of intoxicating liquor in the original package at retail between the hours of 9:00 a.m. and 12:00 midnight on Sundays.

\$300.00 per year

_____ **FOR MANUFACTURERS, OTHER THAN MICROBREWERS**

For a manufacturer, other than a microbrewer, distiller, or brewer of intoxicating liquor.

\$375.00

_____ **FOR WHOLESALER OF INTOXICATING LIQUOR**

For a wholesaler of intoxicating liquor.

\$150.00

_____ **FOR MICROBREWERS**

For Microbrewers a fee of \$7.50 for each one hundred barrels or fraction thereof, up to a maximum fee of

_____ **TEMPORARY LICENSE**

Not more than seven (7) days and if the event will be held on a Sunday, the permit shall begin at 11:00 a.m. **\$25.00**
