

COURT ORDER

VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES

EFFECTIVE MAY 1, 2019

Pursuant to 479.050, RSMo, Supreme Court Rule 37.49, the undersigned Municipal Judge of the City of Crestwood hereby orders that the following designated offenses shall be payable to the City of Crestwood Violations Bureau. In such cases, no court appearance is necessary.

Part I consists of the St. Louis County Municipal Court Uniform Traffic Violation Schedule, for moving violations (points).

Part II consists of the St. Louis County Municipal Court Uniform Traffic Violation Schedule for non-moving violations.

Part III consists of non-traffic ordinance violations which can be paid out of court as imposed by the City of Crestwood.

Court Costs

In accordance with Missouri statutes and ordinances adopted by the City, total Court Costs shall be \$28.50. This includes standard court cost of \$12.00, Crime Victim's Compensation Surcharge of \$7.50, Domestic Violence \$4.00, Law Enforcement Training Fund of \$1.00, Peace Officer's Standard Training Fund of \$2.00 and Inmate Security Fund of \$2.00.

Court costs shall be paid in addition to the fine.
